With my growing interest in the field of technology and IP as well as a background in ESG, I focused on attending sessions centering these topics to garner newer perspectives. For example, I shared my experience in the ESG session, stating the disparities between developed and developing nations and the responsibility in environmental protection. Nepal has rich and diverse landscape for resources yet the rampant and haphazard constructions do not follow due processes, ending up in corrupted practices over the years. It was further amplified in the session of AI and Climate Change, which showcased that innovation often comes at the expense of the environment (data centers requiring massive energy to run and a singular AI prompt taking so much energy). The world is heading towards a transformative era with massive technological leaps and yet, the law seems to be limited, with the idea of its restriction rather than accommodating the growing space.

On the other hand, the social aspect of ESG is seen in labor and employment spaces. In the realization of IP protection, I learnt about the implications of NDA. The culture of formal employment agreements is slowly steeping into the Nepali labor market but a full-fledged NDA is rarely heard of. Thus, the requirement of non-disclosure even after termination was a new and diverse perspective I learnt in the field of IP protection. Even in areas of international investment, which has been a key driver of economic growth in Nepal, I realized the importance of IP protection to encourage investors and build trust. This also connected to the trade wars across the world, and highlighted the restriction on black markets or boot-leg sellers.

One of the sessions that really made a difference for me was the session with Women Lawyers Conquering Challenges. As a woman lawyer myself, I alongside all the participants in the room felt a sense of solidarity when the speakers spoke of balancing their work and home life, a double standard often not expected of men lawyers. The guilt of wanting to grow in your career instead of wanting a family felt like betraying traditional beliefs but sitting there with all others, I knew I did not want to be ashamed of my achievements but to celebrate it. I truly felt seen and heard.

I have no doubt that the IPBA Annual Meeting in Chicago is going to be a shaping factor in my upcoming legal career. I am finding my footing and this experience has helped me stay grounded to my values so that I can take a stand fearlessly and move with dignity. The IPBA imprinted in me, nothing but warm memories of people, places and parties that we got to dance in. I cannot wait to contribute to the growth of this wonderful organization.
